## **MENTAL HEALTH PARITY REGULATIONS VIRTUAL PUBLIC HEARING NOTICE AND AGENDA**

On or before December 31, 2021, the Commissioner is required, in consultation with interested stakeholders, to adopt regulations implementing the provisions of § 15-144, which requires health carriers to report on compliance with the federal Mental Health Parity and Addiction Equity Act (MHPAEA). Pursuant to uncodified language in the legislation adopting the reporting requirements, the form of the report required under § 15-144(c) is the National Association of Insurance Commissioners' (NAIC) Data Collection Tool for Mental Health Parity Analysis, Nonquantitative Treatment Limitations (the "NAIC MHPAEA Tool"), as amended by the Commissioner to incorporate the requirements of § 15-144(c), (d) and (e).

The Commissioner held public informational meetings on November 23, 2020, April 26, 2021, and August 31, 2021 to hear from subject matter experts and interested stakeholders on, among other things, those nonquantitative treatment limitations (NQTL) that should be the subject of reporting.

The Commissioner posted draft regulations and draft reporting templates with instructions. Written comments were received and reviewed. Proposed regulations, which were revised based on the comments received, have been submitted for publication in the Maryland Register. The Commissioner has also posted revised templates and instructions to the MIA website.

Many of the public comments addressed concerns about the draft data reporting supplements (data supplements) to allow uniform reporting of data to verify the analysis to show that an NQTL complies with MHPAEA in operation. The Commissioner maintains that an evaluation of quantitative data is essential for completing the "in operation" analysis, and that certain data elements in addition to the specific items included in the data report required by § 15-144(f) are necessary in order to address all of the different NQTLs that will be reported under § 15-144. The Commissioner has not posted revisions to the data supplements, but is asking for

stakeholders to provide additional comments on whether the data supplements should be required at the same time as the report required by § 15-144 of the Insurance Article, at a later date, or as a separate data call. The Commissioner is also interested in comments on the cost of compliance with specific data elements requested in the data supplements, and whether these costs are in addition to the costs of compliance with the MHPAEA reporting requirements of 42 U.S.C. § 300gg-26(a)(8), in particular for health plans that use the Self-Compliance Tool published by the Department of Labor, including the appendices to the Self-Compliance Tool.

The Commissioner hereby invites oral comments from interested stakeholders on the data supplements and the draft proposed reporting templates and instructions.
