A BILL ENTITLED

1 AN ACT concerning

2 **Insurance – Public Adjusters**

3 FOR the purpose of altering certain provisions concerning the licensing and practice of
4 public adjusters; adding and altering certain definitions relating to public adjusters;
5 providing an exception to licensing for certain marketing activities; repealing the
6 requirement that public adjuster license application forms include certain
7 employment disclosures; altering the title that a licensed public adjuster may use;
8 repealing the requirement for certain experience before taking a certain written
9 examination; establishing certain requirements for the payment of fees,
10 commissions, or other consideration to a public adjuster; requiring a public adjuster
11 contract to be in writing and to include certain terms; requiring a public adjuster to
12 make certain disclosures to an insured in a certain manner; requiring a public
13 adjuster to deposit certain funds in an escrow account in a certain manner; requiring
14 a public adjuster to maintain certain records for a certain period; providing for the
15 examination of certain records; requiring that certain records be kept confidential in
16 a certain manner; establishing certain standards of conduct for a public adjuster;
17 establishing certain ethical requirements for a public adjuster; requiring a public
18 adjuster to disclose certain administrative actions or criminal prosecution to the
19 Maryland Insurance Commissioner; making stylistic changes; providing for the
20 application of this Act; providing for a delayed effective date; and generally relating
21 to public adjusters.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Insurance**

19 10–401.

20 (a) In this subtitle the following words have the meanings indicated.

21 (b) “Business entity” has the meaning stated in § [10–101(c)] **10–101** of this title.

22 (c) **“HOME STATE” MEANS:**

23 (1) THE STATE WHERE A PUBLIC ADJUSTER’S PRINCIPAL PLACE OF
24 RESIDENCE OR PRINCIPAL PLACE OF BUSINESS IS LOCATED; OR

25 (2) THE STATE A PUBLIC ADJUSTER DESIGNATES UNDER §
26 10–409(A)(2) OF THIS SUBTITLE.

(D) “IMMEDIATE FAMILY MEMBER” MEANS A PUBLIC ADJUSTER’S:

(1) SPOUSE;

(2) CHILD;

(3) CHILD’S SPOUSE;

(4) PARENT;

(5) SPOUSE’S PARENT;

(6) SIBLING; OR

(7) SIBLING’S SPOUSE.

[(c)] (E) “License” means a license issued by the Commissioner to act as a public adjuster.

(F) “MARKETING” MEANS THE DISTRIBUTION OF ADVERTISING MATERIALS REGARDING THE SERVICES OF A PUBLIC ADJUSTER.

[(d)] (G) (1) “Public adjuster” means a person [that:

(i) solicits business or represents itself to the public as an adjuster of first party insurance claims for losses or damages arising under insurance contracts that insure the real or personal property, or both, of an insured;

(ii) receives compensation for investigating, appraising, evaluating, or otherwise giving advice or help to an insured in the adjustment of claims for losses or damages arising under insurance contracts that insure the real or personal property, or both, of an insured; or

(iii) for compensation, directly or indirectly, solicits business, investigates or adjusts losses, or advises an insured about insurance claims for losses or damages arising under insurance contracts that insure the real or personal property, or both, of an insured for another person engaged in the business of adjusting losses or

1 damages arising under insurance contracts that insure the real or personal property, or
2 both, of an insured] WHO FOR COMPENSATION OR ANY OTHER THING OF VALUE:

3 (I) ACTS OR AIDS, SOLELY IN RELATION TO FIRST-PARTY
4 CLAIMS ARISING UNDER AN INSURANCE POLICY THAT INSURES THE REAL OR
5 PERSONAL PROPERTY OF THE INSURED, ON BEHALF OF THE INSURED IN
6 NEGOTIATING FOR, OR EFFECTING THE SETTLEMENT OF, A CLAIM FOR LOSS OR
7 DAMAGE COVERED BY AN INSURANCE POLICY;

8 (II) EXCEPT AS PROVIDED IN § 10-403 OF THIS SUBTITLE,
9 DIRECTLY OR INDIRECTLY SOLICITS FOR EMPLOYMENT AS A PUBLIC ADJUSTER OF
10 INSURANCE CLAIMS, SOLICITS BUSINESS, OR REPRESENTS ONESELF TO THE PUBLIC
11 AS A PUBLIC ADJUSTER OF FIRST-PARTY INSURANCE CLAIMS FOR LOSSES OR
12 DAMAGES ARISING OUT OF INSURANCE POLICIES THAT INSURE REAL OR PERSONAL
13 PROPERTY; OR

14 (III) INVESTIGATES OR ADJUSTS LOSSES, OR ADVISES AN
15 INSURED ABOUT FIRST-PARTY CLAIMS FOR LOSSES OR DAMAGES ARISING OUT OF
16 AN INSURANCE POLICY THAT INSURES REAL OR PERSONAL PROPERTY FOR
17 ANOTHER PERSON ENGAGED IN THE BUSINESS OF ADJUSTING LOSSES OR DAMAGES
18 COVERED BY AN INSURANCE POLICY, FOR THE INSURED.

19 (2) "Public adjuster" does not include a person that investigates, adjusts,
20 or appraises claims for loss or damage covered by a motor vehicle insurance policy.

21 10-402.

22 This subtitle does not apply to:

23 (1) an adjuster for or an insurance producer or employee of an insurer or
24 group of insurers under common control or ownership that, as representative of the insurer
25 or group, adjusts losses or damages under policies issued by the insurer or group;

26 (2) an insurance producer that acts as an adjuster without compensation
27 for an insured for whom the insurance producer is acting as an insurance producer; [or]

28 (3) an attorney at law who does not:

(i) regularly act as a public adjuster; and

(ii) represent to the public by sign, advertisement, or otherwise that the attorney at law acts as a public adjuster;

(4) A PERSON WHO NEGOTIATES OR SETTLES CLAIMS ARISING UNDER:

(I) A LIFE, HEALTH, OR MOTOR VEHICLE INSURANCE POLICY; OR

(II) AN ANNUITY CONTRACT;

(5) A PERSON EMPLOYED ONLY FOR THE PURPOSE OF OBTAINING FACTS SURROUNDING A LOSS OR FURNISHING TECHNICAL ASSISTANCE TO A PUBLIC ADJUSTER, INCLUDING A PHOTOGRAPHER, AN ESTIMATOR, A PRIVATE INVESTIGATOR, AN ENGINEER, AND A HANDWRITING EXPERT;

(6) A LICENSED HEALTH CARE PROVIDER, OR AN EMPLOYEE OF A LICENSED HEALTH CARE PROVIDER, WHO PREPARES OR FILES A HEALTH CLAIM FORM ON BEHALF OF A PATIENT; OR

(7) A PERSON WHO SETTLES SUBROGATION CLAIMS BETWEEN INSURERS.

10-403.

(a) Except as otherwise provided in this subtitle, a person must obtain a license before the person acts as a public adjuster in the State.

(b) **MARKETING ON BEHALF OF A PUBLIC ADJUSTER, AS DEFINED IN § 10-401 OF THIS SUBTITLE, DOES NOT REQUIRE A LICENSE.**

(c) A person that violates this section is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$500 or imprisonment not exceeding 6 months or both for each violation.

10-405.

1 (a) An applicant for an initial license shall file with the Commissioner an
2 application on the form that the Commissioner provides.

3 (b) The application form shall require:

4 (1) the name and address of the applicant;

5 (2) whether any other insurance license or certificate has been issued to
6 the applicant;

7 (3) [the business in which the applicant has been engaged for the 5 years
8 immediately preceding the date of application and, if employed by another, the name and
9 address of each employer;

10 (4)] for a business entity applicant:

11 (i) the name of the individual licensed public adjuster employed by
12 the business entity who is designated to act as the business entity's principal contact with
13 the Administration; and

14 (ii) the name and address of each licensed public adjuster employed
15 by the business entity, each individual who has direct control over its fiscal management,
16 each owner, partner, member, or manager of the business entity, and each director of a
17 business entity that is a corporation; and

18 [(5)] (4) any other information that the Commissioner requires of
19 applicants to enable the Commissioner to determine the trustworthiness and competence
20 of the applicant to transact business as a public adjuster so as to safeguard the interests of
21 the public.

22 (c) An application shall be signed under oath:

23 (1) in the case of an individual applicant, by the applicant; or

24 (2) in the case of an applicant that is a business entity, by an individual
25 who has direct control over its fiscal management, an owner, partner, member, or manager
26 of the business entity, or a director of a business entity that is a corporation.

1 10-406.

2 [(a)] The Commissioner shall issue a license to each applicant who meets the
3 requirements of this subtitle.

4 [(b)] A person that is licensed as a public adjuster under this subtitle may be known
5 as a "certified public adjuster".]

6 10-407.

7 The Commissioner [shall] MAY adopt regulations that specify:

8 (1) the scope, type, conduct, and grading of the written examination; AND

9 (2) the frequency, times, and locations within the State where the written
10 examination will be held[; and

11 (3) the experience requirements for an individual applicant to be eligible to
12 take a written examination].

13 10-409.

14 (a) (1) Except as otherwise provided in this section, the Commissioner shall
15 waive the license requirements for an applicant who is not a resident of the State if:

16 [(1)] (I) the applicant has a valid public adjuster license from the home
17 state of the applicant; and

18 [(2)] (II) the home state of the applicant awards nonresident public
19 adjuster licenses to residents of the State on the same basis.

20 (2) IF NEITHER THE STATE WHERE THE PUBLIC ADJUSTER
21 MAINTAINS A PRINCIPAL PLACE OF RESIDENCE NOR THE STATE WHERE THE PUBLIC
22 ADJUSTER MAINTAINS A PRINCIPAL PLACE OF BUSINESS HAS A LAW GOVERNING
23 PUBLIC ADJUSTERS SUBSTANTIALLY SIMILAR TO THIS SUBTITLE, THE PUBLIC
24 ADJUSTER MAY DECLARE ANOTHER STATE WHERE THE PUBLIC ADJUSTER IS

1 LICENSED AND ACTS AS A PUBLIC ADJUSTER TO BE THE PUBLIC ADJUSTER'S HOME
2 STATE FOR PURPOSES OF THIS SUBTITLE.

3 (b) Unless denied a license [pursuant to] UNDER § 10–410 of this subtitle, a
4 person [that] WHO is not a resident of the State may obtain a nonresident license to act as
5 a public adjuster if:

6 (1) the person currently is licensed as a resident public adjuster and in good
7 standing in the person's home state;

8 (2) the person files an application on the form that the Commissioner
9 provides;

10 (3) the person has paid the applicable fee pursuant to § 2–112 of this
11 article; and

12 (4) the person's home state awards nonresident public adjuster licenses to
13 residents of this State on the same basis.

14 (c) A person who is not a resident of this State and whose home state does not
15 issue a public adjuster license must meet the license requirements of §§ 10–404 and
16 10–405 of this subtitle.

17 10–409.1.

18 (A) Except as otherwise expressly provided by law, a person may not pay, allow,
19 or give, or offer to pay, allow, or give, directly or indirectly, any valuable consideration to
20 an insured as an inducement to use the services of a public adjuster.

21 (B) A PUBLIC ADJUSTER MAY PAY A COMMISSION, SERVICE FEE, OR ANY
22 OTHER VALUABLE CONSIDERATION TO A PERSON ONLY IF THAT PERSON IS
23 REQUIRED TO BE LICENSED, AND IS LICENSED, AS A PUBLIC ADJUSTER.

24 (C) A PERSON MAY NOT ACCEPT A COMMISSION, SERVICE FEE, OR ANY
25 OTHER VALUABLE CONSIDERATION IF THE PERSON IS REQUIRED TO BE LICENSED,
26 BUT IS NOT LICENSED, AS A PUBLIC ADJUSTER.

27 10–410.

1 (a) The Commissioner may deny a license to an applicant or suspend, revoke, or
2 refuse to renew or reinstate a license after notice and opportunity for a hearing under §§
3 2–210 through 2–214 of this article if the applicant or licensee:

4 (1) has violated this article;

5 (2) has made a material misstatement in the application for the license;

6 (3) has engaged in fraudulent or dishonest practices;

7 (4) has demonstrated incompetency or untrustworthiness to act as a public
8 adjuster;

9 (5) has misappropriated, converted, or unlawfully withheld money that
10 belongs to an insurer, insurance producer, insured, or other person;

11 (6) has willfully and materially misrepresented the provisions of a policy;

12 (7) has been convicted of a felony, a crime of moral turpitude, or any
13 criminal offense involving dishonesty or breach of trust;

14 (8) has willfully failed to comply with or has willfully violated a proper
15 order or regulation of the Commissioner;

16 (9) has failed or refused to pay on demand money that belongs to an
17 insurer, insurance producer, insured, or other person entitled to the money;

18 (10) is not carrying on or does not intend to carry on business in good faith
19 while representing to the public that the person is a public adjuster;

20 (11) has been denied a license or has had a license suspended or revoked in
21 another state; or

22 (12) has knowingly employed or knowingly continued to employ an
23 individual acting in a fiduciary capacity who has been convicted within the preceding 10
24 years of a felony or crime of moral turpitude.

1 (b) (1) The Commissioner may deny a license to a business entity applicant or
2 suspend, revoke, or refuse to renew or reinstate the license of a business entity after notice
3 and opportunity for a hearing under §§ 2–210 through 2–214 of this article, if an individual
4 listed in paragraph (2) of this subsection:

5 (i) violates any provision of this article;

6 (ii) is convicted of a felony, a crime of moral turpitude, or any
7 criminal offense involving dishonesty or breach of trust; or

8 (iii) has any professional license suspended or revoked for a
9 fraudulent or dishonest practice.

10 (2) The sanctions provided for under this subsection may be imposed on a
11 business entity if the violation was committed by an individual who:

12 (i) is a public adjuster employed by the business entity;

13 (ii) 1. in the case of a limited liability company, is an officer,
14 director, member, or manager;

15 2. in the case of a partnership, is a partner; and

16 3. in the case of a corporation, is a director, officer, or
17 controlling owner; or

18 (iii) has direct control over the fiscal management of the business
19 entity.

20 (c) Instead of or in addition to suspending or revoking the license of a public
21 adjuster, the Commissioner may impose on the licensee a penalty of not less than \$100 but
22 not exceeding \$500 for each violation of this article.

23 (d) Instead of or in addition to suspending or revoking the license, the
24 Commissioner may require that restitution be made to any citizen who has suffered
25 financial injury because of the violation of this article.

1 (e) If the license is suspended under this section, the Commissioner may require
2 the individual to pass an examination and file a new application before the suspension is
3 lifted.

4 10-411.

5 (A) A CONTRACT FOR PUBLIC ADJUSTER SERVICES SHALL:

6 (1) BE IN WRITING;

7 (2) BE TITLED "PUBLIC ADJUSTER CONTRACT"; AND

8 (3) CONTAIN THE FOLLOWING:

9 (I) THE LEGIBLE FULL NAME OF THE PUBLIC ADJUSTER
10 SIGNING THE CONTRACT, AS SPECIFIED IN THE RECORDS OF THE ADMINISTRATION;

11 (II) THE PERMANENT BUSINESS ADDRESS AND PHONE NUMBER
12 OF THE PUBLIC ADJUSTER IN THE PUBLIC ADJUSTER'S HOME STATE;

13 (III) THE LICENSE NUMBER ISSUED BY THE ADMINISTRATION TO
14 THE PUBLIC ADJUSTER;

15 (IV) THE INSURED'S FULL NAME, STREET ADDRESS, INSURANCE
16 COMPANY NAME, AND POLICY NUMBER, IF KNOWN OR ON NOTIFICATION;

17 (V) A DESCRIPTION OF THE LOSS AND THE LOCATION OF THE
18 LOSS, IF APPLICABLE;

19 (VI) A DESCRIPTION OF SERVICES TO BE PROVIDED TO THE
20 INSURED;

21 (VII) THE SIGNATURES OF THE PUBLIC ADJUSTER AND THE
22 INSURED;

23 (VIII) THE DATES WHEN THE CONTRACT WAS SIGNED BY THE
24 PUBLIC ADJUSTER AND THE INSURED, RESPECTIVELY;

1 (IX) AN ATTESTATION THAT THE PUBLIC ADJUSTER IS FULLY
2 BONDED IN ACCORDANCE WITH STATE LAW;

3 (X) NOTIFICATION TO THE INSURED THAT:

4 1. THE PUBLIC ADJUSTER MAY INCUR OUT-OF-POCKET
5 EXPENSES ON BEHALF OF THE INSURED; AND

6 2. THESE EXPENSES INCURRED BY THE PUBLIC
7 ADJUSTER AND APPROVED BY THE INSURED WILL BE REIMBURSED TO THE PUBLIC
8 ADJUSTER FROM THE INSURANCE PROCEEDS; AND

9 (XI) THE FULL SALARY, FEE, COMMISSION, COMPENSATION, OR
10 OTHER CONSIDERATION THE PUBLIC ADJUSTER IS TO RECEIVE FOR SERVICES.

11 (B) (1) THE PUBLIC ADJUSTER CONTRACT MAY SPECIFY THAT THE
12 PUBLIC ADJUSTER BE NAMED AS A CO-PAYEE ON AN INSURER'S PAYMENT OF A
13 CLAIM.

14 (2) IF THE COMPENSATION IS BASED ON A SHARE OF THE INSURANCE
15 SETTLEMENT, THE PUBLIC ADJUSTER CONTRACT SHALL SPECIFY THE EXACT
16 PERCENTAGE TO BE PAID.

17 (3) (I) A COMPENSATION PROVISION IN A PUBLIC ADJUSTER
18 CONTRACT MAY NOT BE REDACTED IN ANY COPY OF THE CONTRACT PROVIDED TO
19 THE COMMISSIONER.

20 (II) A REDACTION OF A COMPENSATION PROVISION
21 CONSTITUTES AN OMISSION OF MATERIAL FACT IN VIOLATION OF THIS SUBTITLE.

22 (C) IF THE INSURER, WITHIN 72 HOURS AFTER THE TIME THE LOSS IS
23 REPORTED TO THE INSURER, EITHER PAYS OR COMMITS IN WRITING TO PAY TO THE
24 INSURED THE POLICY LIMIT OF THE INSURANCE POLICY, THE PUBLIC ADJUSTER:

25 (1) MAY NOT RECEIVE A COMMISSION CONSISTING OF A PERCENTAGE
26 OF THE TOTAL AMOUNT PAID BY AN INSURER TO RESOLVE A CLAIM;

1 (2) SHALL INFORM THE INSURED THAT LOSS RECOVERY AMOUNT
2 MIGHT NOT BE INCREASED BY THE INSURER; AND

3 (3) MAY BE ENTITLED ONLY TO REASONABLE COMPENSATION FROM
4 THE INSURED FOR SERVICES THE PUBLIC ADJUSTER PROVIDES ON BEHALF OF THE
5 INSURED, BASED ON THE TIME SPENT ON A CLAIM AND EXPENSES INCURRED BY THE
6 PUBLIC ADJUSTER, UNTIL THE CLAIM IS PAID OR THE INSURED RECEIVES A
7 WRITTEN COMMITMENT TO PAY FROM THE INSURER.

8 (D) (1) A PUBLIC ADJUSTER SHALL PROVIDE TO THE INSURED A WRITTEN
9 DISCLOSURE SIGNED BY THE PUBLIC ADJUSTER AND THE INSURED CONCERNING
10 ANY DIRECT OR INDIRECT FINANCIAL INTEREST THAT THE PUBLIC ADJUSTER OR
11 ANY IMMEDIATE FAMILY MEMBER OF THE PUBLIC ADJUSTER HAS WITH ANY OTHER
12 PARTY THAT IS INVOLVED IN ANY ASPECT OF THE CLAIM, OTHER THAN THE SALARY,
13 FEE, COMMISSION, OR OTHER CONSIDERATION ESTABLISHED IN THE WRITTEN
14 CONTRACT WITH THE INSURED.

15 (2) THE DISCLOSURE SHALL INCLUDE ANY OWNERSHIP OF, OR ANY
16 COMPENSATION EXPECTED TO BE RECEIVED FROM, ANY CONSTRUCTION FIRM,
17 SALVAGE FIRM, BUILDING APPRAISAL FIRM, MOTOR VEHICLE REPAIR SHOP, OR ANY
18 OTHER FIRM THAT PROVIDES ESTIMATES FOR WORK, OR THAT PERFORMS ANY
19 WORK, IN CONJUNCTION WITH DAMAGES CAUSED BY THE INSURED LOSS ON WHICH
20 THE PUBLIC ADJUSTER IS ENGAGED.

21 (E) A PUBLIC ADJUSTER CONTRACT MAY NOT CONTAIN ANY PROVISION
22 THAT:

23 (1) ALLOWS THE PUBLIC ADJUSTER'S PERCENTAGE FEE TO BE
24 COLLECTED WHEN MONEY IS DUE FROM, BUT NOT YET PAID BY, AN INSURANCE
25 COMPANY;

26 (2) ALLOWS A PUBLIC ADJUSTER TO COLLECT THE ENTIRE FEE FROM
27 THE FIRST CHECK ISSUED BY AN INSURANCE COMPANY, RATHER THAN AS A
28 PERCENTAGE OF EACH CHECK ISSUED BY AN INSURANCE COMPANY;

29 (3) REQUIRES THE INSURED TO AUTHORIZE AN INSURANCE COMPANY
30 TO ISSUE A CHECK ONLY IN THE NAME OF THE PUBLIC ADJUSTER; OR

(4) PRECLUDES EITHER PARTY FROM PURSUING ANY CIVIL REMEDY.

(F) BEFORE THE SIGNING OF THE PUBLIC ADJUSTER CONTRACT, THE PUBLIC ADJUSTER SHALL PROVIDE THE INSURED WITH A SEPARATE DISCLOSURE DOCUMENT SIGNED BY THE INSURED REGARDING THE CLAIM PROCESS THAT SUBSTANTIALLY STATES:

“(1) PROPERTY INSURANCE POLICIES OBLIGATE THE INSURED TO PRESENT A CLAIM TO THE INSURANCE COMPANY FOR CONSIDERATION. THERE ARE THREE TYPES OF ADJUSTERS THAT COULD BE INVOLVED IN THAT PROCESS. THE DEFINITIONS OF THE THREE TYPES ARE:

(I) “COMPANY ADJUSTER” MEANS AN INSURANCE ADJUSTER WHO IS AN EMPLOYEE OF AN INSURANCE COMPANY. A COMPANY ADJUSTER REPRESENTS THE INTEREST OF THE INSURANCE COMPANY AND IS PAID BY THE INSURANCE COMPANY. A COMPANY ADJUSTER WILL NOT CHARGE YOU A FEE.

(II) “INDEPENDENT ADJUSTER” MEANS AN INSURANCE ADJUSTER WHO IS HIRED ON A CONTRACTUAL BASIS BY AN INSURANCE COMPANY TO REPRESENT THE INSURANCE COMPANY’S INTEREST IN THE SETTLEMENT OF THE CLAIM. AN INDEPENDENT ADJUSTER IS PAID BY YOUR INSURANCE COMPANY. AN INDEPENDENT ADJUSTER WILL NOT CHARGE YOU A FEE.

(III) “PUBLIC ADJUSTER” MEANS AN INSURANCE ADJUSTER WHO DOES NOT WORK FOR ANY INSURANCE COMPANY. A PUBLIC ADJUSTER WORKS FOR THE INSURED TO ASSIST IN THE PREPARATION, PRESENTATION, AND SETTLEMENT OF A CLAIM.
