Re: Form A for Acquisition of Evergreen Health, Inc.

Dear Commissioner Redmer:

On behalf of JARS Health Investments, LLC, Anne Arundel Health System, Inc., and LBH Evergreen Holdings, LLC (collectively, the "Applicants"), we submit the enclosed Form A Statement Regarding the Acquisition or Control of or Merger With a Domestic Insurer ("Form A"), seeking approval of the acquisition of Evergreen Health, Inc. ("Evergreen Health") by the Applicants.

In accordance with § 7-106(a) of the Insurance Article of the Annotated Code of Maryland, all information and documents filed with the Maryland Insurance Commissioner (the "Commissioner") in compliance with the requirements of Title 7 of the Insurance Article or that are reported to, obtained by, or otherwise disclosed to the Commissioner or any other person in the course of an examination or investigation made under Title 7 of the Insurance Article: (i) are confidential material; (ii) are not subject to subpoena; (iii) may not be made public by the Commissioner, the National Association of Insurance Commissioners or any other person; and (iv) are not subject to discovery or admissible in evidence in any civil action.

There are two statutory exceptions to this prohibition. First, under Insurance Article, § 7-106(b), material that otherwise is confidential may be made public by any person who has received prior written consent of the person to whom the material relates. Second, under Insurance Article, § 7-106(c), the Commissioner may make public all or part of the confidential material in an appropriate manner if, after giving the person to whom the material relates notice and an opportunity to be heard, the Commissioner determines that it is in the interest of Evergreen Health's policyholders or the public to make otherwise confidential material public.
