The Insurance Commissioner proposes to amend Regulation .10 under COMAR 31.03.02 Insurance Producers — Continuing Education Requirements.

Statement of Purpose

The purpose of this action is to amend COMAR 31.03.02.10, pursuant to Ch. 102 (S.B. 29), Acts of 2019, by decreasing from 15 to 10 the number of days a provider has to report continuing education course completion.

The State Board of Elections proposes to amend Regulation .17 under COMAR 33.10.01 EVS Voting Solution. This action was considered by the State Board of Elections at its September 26, 2019, meeting, notice of which was given in accordance with General Provisions Article, §3-302 (c), Annotated Code of Maryland.

Statement of Purpose

The purpose of this action is to amend the regulation to include the 1) options for ballot packaging; 2) definition and requirements for a ballot stub; 3) definition and requirements for a ballot pack; and 4) protocol for when a local board opens a ballot pack prior to delivery to an early voting center or polling place.

Comparison to Federal Standards

There is no corresponding federal standard to this proposed action.

.17 Ballots — In General.

A. — E. (text unchanged)

F. Ballot [Stub] Packaging.

(1) Each local board shall notify the State Administrator no later than 5 months prior to the start of early voting for a primary election and no later than 4 months prior to a general election whether it wishes to receive pre-printed ballots packaged in accordance with §F(2) or (3) of this regulation.

[(1)] (2) [Each pre-printed ballot shall have an attached, single-perforated stub.] Ballot Stub. Pre-printed ballots packaged in this manner shall have an attached, single-perforated stub. Each ballot stub shall:

- (a) Include the same information that Election Law Article, Annotated Code of Maryland, requires for the ballot heading; and
- (b) Be serially numbered to facilitate ballot accounting.
