## Subtitle 10 HEALTH INSURANCE— GENERAL

### 31.10.51 Mental Health Benefits and Substance Use Disorder Benefits — Reports on Nonquantitative Treatment Limitations and Data

Authority: Insurance Article, §§2-109(a)(1) and 15-144, Annotated Code of Maryland

On August 26, 2025, the Maryland Insurance Administration adopted amendments to Regulations .03 and .04, the repeal of existing Regulation .05, amendments to and the recodification of existing Regulations .06 and .07 to be Regulations .05 and .06, and the recodification of existing Regulation .08 to be Regulation .07 under **COMAR 31.10.51 Mental Health Benefits and Substance Use Disorder Benefits—Reports on Nonquantitative Treatment Limitations and Data Notices of Cancellation, Nonrenewal, Premium Increase, and Reduction in Coverage**. This action, which was proposed for adoption in 52:10 Md. R. 507—508 (May 16, 2025), has been adopted with the nonsubstantive changes shown below.

#### Attorney General's Certification

In accordance with State Government Article, §10-113, Annotated Code of Maryland, the Attorney General certifies that the following changes do not differ substantively from the proposed text. The nature of the changes and the basis for this conclusion are as follows:

Regulation .05: add clarifying language to proposed revisions to COMAR 31.10.51.05B to make it clear that the new state-specific requirement under Insurance Article, §15-144(c)(1)(iv), Annotated Code of Maryland, that carriers must provide the full comparative analysis to members within 30 days of a written request still applies in addition to the requirement in the regulation that the summary form must be made available to members within 30 days of a request.

The edit to this text further clarifies that those requirements are unaltered by the regulation. This change could have reasonably been anticipated as public comment indicated that such clarification would be appreciated, and the change does not in any way change the burden on entities subject to the text nor does it impact any benefit to such entities that would have otherwise been realized.

#### .05 Summary Form.

B. The summary form shall be made available to plan members and accessible to the public on the carrier's website no later than [April 1, 2022 and April 1, 2024] *30 days following the due date of each analysis report. In addition to the requirement under Insurance Article, § 15-144(c)(1)(iv), Annotated Code of Maryland that a carrier must provide the full comparative analysis to a member within 30 days of a written request, the* [[The]] carrier shall make the summary form available to plan members in response to a written request within 30 days of the request.
