#### Legislative Updates: SB 93, SB 96

Erica Bailey provided an overview of SB 93. SB 93 will change the nonresident licensing statue to require a nonresident to possess a valid home state license in order to obtain and maintain a nonresident license. The Commissioner will also be able to cancel a nonresident license if the home state license is no longer valid.

Erica Bailey introduced Michael Paddy, Director of Government Affairs. Michael Paddy provided an overview of legislative updates from the 2020 legislative session. Specifically, Michael Paddy discussed Senate Bill 96, which will change the renewal date for Third Party Administrators licenses from every other June 30<sup>th</sup>, to a staggered renewal date. Michael Paddy opened the floor for questions. Michael Paddy also stated that the Maryland General Assembly had adjourned.

Associate Commissioner Erica Bailey discussed the Producer Advisory Board elections. The elections will be conducted to appoint members interested in acquiring roles on the Producer Advisory Board.
