Update Concerning One-Part Examination

Erica Bailey discussed the updates to the one-part examination. The administration has made the decision to convert from the two-part examination to the one-part examination.

Erica Bailey noted many concerns have been raised over time and the administration has carefully examined all possible outcomes of converting to the one-part examination.

The administration will covert to the one-part examination as early as October 2021. The content outlines and exam content will be reviewed in the near future.

Shelley Taylor-Barnes stated the administration is working very hard and all vendors and providers will be notified of the changes, and stated that there is a communication plan intact to properly disperse information.

Erica Bailey opened the floor for the board to offer comments and suggestions.

Producer Licensing Model Act- Lines Of Authority Name Change

Erica Bailey, discussed the implementation of three Lines of Authority changes in order to comply with the Producer Licensing Model Act (PLMA) line of authority names. Effective October 2021 an update will be made to the following Lines of Authorities:

- 1. Variable Life and Variable Annuity Products changes to Variable Life and Variable Annuity
- 2. Health changes to Accident and Health or Sickness
- 3. Credit Products changes to Credit.

Erica Bailey opened the floor for feedback from the Producer Advisory Board.

Update regarding Producer Advisory Board Member Terms and Member Applications

Erica Bailey informed the Producer Advisory Board that Bulletin 21-14 was posted on our website for interested parties to apply to serve on the Producer Advisory Board. Applications are due June 30, 2021.

Existing Producer Advisory Board members that currently have an expired term received letters to submit new applications for reappointment, if interested.
